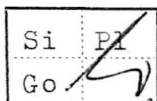

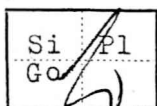

We received December last 1964 Claims Forms for registration of Nazi persecution
my name Jean Marie Rossi born in St Helier Jersey Sep 7. 1898
my son Marcel Fortune Rossi born in Sutton Bridge Lincolnshire Dec 14 1921
last time I saw him was in Harresbruck concentration camp Feb 1945 he fell ill with
pneumonia we were in same camps till this camp was evacuated, we were then parted
by what I have gathered he was sent to Flossenbug with other sick. I have made
many enquiries but without results

We were sent away by the Germans for no reason at all Feb 1943. since receiving these
forms. my wife has died Feb 7 1965. This was reason these forms were not filled in before

I am enclosing birth certificates etc. here is a list of camps we were in

Kreuzburg a very good camp my number 1487 my son's 1486

Opel goal very bad

Blackhammet AEL very bad

Gross Rosen very very bad

96096

Harresbruck very very bad

cannot remember numbers

I was freed by American Forces April 1945 in Swansdorf

I have filled in as far as can remember and best of my knowledge
